Recordable Instrument Requirements:

- 1. Original Instrument
- 2. Notarized Signature
- 3. Tax Statement Return Address on document
- 4. Name of Instrument Preparer
- 5. Revenue Stamps on Warranty Deeds (if revenue changed hands)
- 6. "I Certify" statement on all Warranty Deeds (and any deed that has revenue stamps attached)
- 7. A self-addressed stamped envelope
- 8. Compliance with Standardized Form Act 757 of 2003 (or refer to Ark. Code Ann. §14-15-203)

Survey and Plat Requirements:

- 1. Original Instrument
- 2. All required signatures on each instrument
- 3. NO Larger than 11x17 in size
- 4. One copy will be stamped with recording information for no additional charge. Any additional copies will be charged the \$5.00 certification fee.
